## Victorian Population Health Survey 2010


### Gippsland Region - selected findings

Gippsland Region is located in eastern Victoria and its estimated resident population as of 2010 was 266,000<sup>1</sup> with adults comprising 77.4% of the population, compared to 77.8% for Victoria<sup>1</sup>. More than one-third of residents (38.8%) were aged 50 years or older compared to 31.4% for Victoria. Life expectancy at birth in 2007 was 84.0 years for females and 78.1 years for males, lower<sup>2</sup> than the Victorian figure of 84.4 years and 80.3 years respectively<sup>3</sup>.

The Victorian Population Health Survey is an annual state-wide survey that the Department of Health undertakes to collect information on the health of the adult Victorian population (18 years or older).

#### **Smoking status**


Current smokers are defined as those who smoke daily or occasionally. In 2010, 21.2% of males and 17.6% of females from the Region were current smokers, similar4 to all Victorian males (17.8%) and females (15.8%).



#### Alcohol consumption<sup>5</sup>

The Australian Alcohol Guidelines<sup>6</sup> specify the risk of long-term alcohol-related harm by level of alcohol consumption in males and females.

The patterns of alcohol consumption were similar between the Region and Victoria. Males (83.4%) in the Region were more likely to consume alcohol at levels that put them at long-term low risk of alcohol-related harm compared to Victorian females (70.8%). Males (10.0%) in the region were far less likely than their female counterparts to abstain from alcohol consumption (22.2%).



#### Overweight and obesity

Being overweight or obese is an important risk factor for developing type 2 diabetes, cardiovascular disease, hypertension, certain cancers, sleep apnoea and osteoarthritis. It is typically measured by calculating a person's Body Mass Index (BMI), which is their weight in relation to their height<sup>7,8</sup>.

In 2010, 45.5% of males and 28.2% of females in the Region were overweight, similar to all Victorian males and females (41.0% and 25.7% respectively). There were higher proportions of males (20.3%) and females (21.0%) in the Region who were obese, compared with Victorian males (18.5%) and females (15.2%). Males in the Region were also more likely to be overweight than their female counterparts.





The 2010 VPHS survey questions on alcohol consumption assessed the risks of alcohol-related harm based on the 2001 Australian Alcohol




#### Nutrition

In 2010, 4.9% of males and 11.6% of females in the Region met the dietary guidelines<sup>9</sup> for vegetable consumption, similar to Victorian males and females (5.2% and 10.0% respectively). More than four in 10 males (43.5%) and 51.3% of females in the Region met the dietary guidelines for fruit consumption, similar to Victorian males and females (45.1% and 54.5% respectively). Females in the Region were also more likely to meet the dietary guidelines for consumption of vegetables, compared with males.



#### **Physical Activity**

In 2010, 57.0% of males and 62.4% of females in the Region met the physical activity guidelines<sup>10</sup>, similar to Victorian males and females (61.2% and 57.1% respectively). There were no differences in physical activity levels between the Region and Victoria overall or between males and females in the Region.



#### Psychological distress


Poor mental health is a significant risk factor for poor health outcomes. The Kessler 10 (K10) scale is a measure of the level of psychological distress, which in turn is a risk factor for poor mental health<sup>11</sup>.

In 2010, 71.4% of males and 62.3% of females in the Region experienced low levels of psychological distress, similar to Victorian males and females (68.9% and 59.9% respectively). There were no differences in psychological distress levels between the Region and Victoria, or between males and females.



#### Self-reported health

In 2010, 40.8% of males and 47.2% of females in the Region reported their health as excellent or very good, similar to Victorian males and females (45.2% and 46.8% respectively). There were no differences between the Region and Victoria, or between males and females in self-reported health status.
