Terms of Reference

- Aim:** To develop a person-centred model of care and associated funding and performance management framework for the delivery of sub-acute ambulatory care services (SACS), taking into account the following principles:
- To provide the most appropriate care for the client;
 - To support a client-focused model of care;
 - To encourage and support continuity of client care;
 - To encourage appropriate use of SACS;
 - To encourage integration of SACS within a health service; and
 - To encourage appropriate transition from inpatient settings and optimise community reintegration.

- Task:** To advise and contribute to the development of the SACS Program Framework.
- To define the components of the SACS model of care, including principles, objectives, core aspects, enablers and barriers
 - To oversee the methodology used to develop the SACS Program Framework.
 - To identify specific requirements for accountability and reporting measures.
 - To oversee any pilot studies that may be implemented to test the model of care; and funding, accountability and reporting framework.
