### Tobacco retailer signage in Victoria

# What mandatory signs do I have to display if I sell tobacco products?

All tobacco retailers must display one of the A4 sized "We don't sell tobacco to U/18s" sign shown below.



You must also display **one** of the A3 health warning/smoking cessation signs shown below.



#### Where should I display these signs?

The U/18 and health warning/smoking cessation sign must be displayed next to each point of sale for tobacco products or near the entrance of your shop where customers can easily see it.

Venues with a tobacco vending machine must either display the signage at each machine or near the entrance to the venue.

All signs must be easy for customers to see.

# Are there additional signage requirements if I have a tobacco price board in my premises?

Yes. If you use a price board, you must display one of these A4 size graphic-health-warning signs on or immediately next to the price board.



These graphic health warnings are used by the Department of Health under licence from the Commonwealth of Australia and may only be used



as permitted by the Department of Health. Graphic health warning signs are available from the Department of Health. # Are there other optional tobacco signs that I can display?

Yes. The A4 'No proof of age, no cigarettes" sign (shown below) may be displayed to shows your customers some of the acceptable forms of identification.



Tobacco retailers may also display an A4 "We sell tobacco here" sign (shown below) to tell customers that they sell tobacco products.
