Adult beds per 10,000 adult population	Number of funded adult general acute inpatient beds per 10,000 population aged 16-64 in catchment of the area mental health service. Specialist units psychiatric are excluded (Veterans, Koori), and beds at Orygen and Melbourne Clinic allocated to relevant AMHS.	<ul style="list-style-type: none"> • No specified benchmark - bed numbers to be expanded in line with Government policy announcements. • Included as a contextual item. • Population figures are Estimated Resident Population (ERP) figures for 1 July 2009.
Local access	Percentage of non-sameday formal separations from adult general acute psychiatric inpatient units who are residents of the AMHS's catchment (as recorded in the MHA (catchment) field).	<ul style="list-style-type: none"> • No specified benchmark – reflection of a service's ability to meet the inpatient mental health needs of people within its catchment. • Based on separation types A, H and N

Long stay patient bed occupancy	Admission hours falling within the reporting period, for "long stay" admissions in adult acute psychiatric inpatient units, as a proportion of funded bed hours for the campus. 28-day Readmission rate	Percentage of non-sameday non-statistical separations from adult acute inpatient units that are followed by a non-sameday non-statistical readmission to any adult acute inpatient unit within 28 days.
